

 - Includes 2 on-site residences



- Targeted for award in August 2009

- **June 2009 – Solicitations Released**
- **August 2009 – Award**
- **Spring 2010 – Construction Starts**
- **February 2012 – Construction Complete**
- **September 2012 – Project Fiscal Close-Out Complete**

- **MATOC (Multiple Award Task Order Contract)**
 - Existing competitively-awarded Design-Build Contract
 - Satisfies the spirit of the Recovery Act by supporting early awards
 - Establishes Small Business goals for prime vendors
- **Small Business Subcontracting Goal:**
 - 70.0% of subcontracted amount goes to small businesses, including:
 - Small Disadvantaged SB
 - Women-Owned SB
 - HubZone SB
 - Veteran-Owned SB
 - Service-Disabled Veteran-Owned SB
